

### ***Preservational Integrity of the United Commonwealth Agreement***

Agreement dated May 9, 2020, between Pelicary (a/k/a Mythopoeia, Zach and hereafter referred to as the “Offeror”), a member of Altverse, and Centrist16 (a/k/a Justin and hereafter referred to as the “Offeree”), a member and the Arbiter of Altverse.

WHEREAS Pelicary is the owner of the United Commonwealth; and

WHEREAS Centrist16 is the Arbiter of Altverse; and

WHEREAS Pelicary wishes to protect the territorial integrity of the United Commonwealth;

WHEREAS Centrist16 wishes to defend the territorial integrity of Pelicary’s country,

NOW THEREFORE, in consideration of the mutual covenants herein contained, and other goods and valuable consideration, it is agreed between the parties as follows:

The entire territorial integrity of the United Commonwealth, as it existed May 9, 2020 (omitting the court-ordered loss of Michigan and the offeror’s waive of Puerto Rico and the U.S. Virgin Islands), shall not be infringed or changed without the consent of the Offeror.

The Offeree agrees to waive his right to reward ownership over all or parts of the United Commonwealth without the written, express consent of the Offeror, whether or not the Offeror remains an active member of Altverse and/or the Constructed Worlds Wiki.

The Offeror shall allow the Offeree to hold the United Commonwealth in trust during the Offeror’s absence from the Project, and to designate custodianship to another party.

For the purposes of this Agreement, the Offeror’s absence shall be in any event whenever the Offeror has not edited or used the Wiki for 30 days or more, the Offeror has not participated or been seen online on Discord, either on the public server or on friend list for 30 days or more, or when the Offeror has left Altverse.

Any third party who becomes involved in the custodianship of the United Commonwealth shall be enjoined to abide in the terms of this agreement.

The Offeree agrees that he or whomever he designates as custodian of the United Commonwealth shall not roleplay the country that fundamentally alters, contradicts, or tampers

with the territorial, ideological, or socioeconomic integrity of the United Commonwealth without the Offeror's consent.

The Offeree agrees that he or whomever he designates shall act in good faith when taking care of the United Commonwealth during the Offeror's absence and for the benefit of the Offeror.

The Offeror acknowledges that any territory he waives cannot be reclaimed without the Offeree's consent.

Any controversy or claim arising out of or relating to this Agreement, or the breach thereof, shall be settled by arbitration in accordance to community guidelines, and judgment upon the award rendered by the arbitrator(s) may be entered in any court having jurisdiction thereof.
