### New Features

#### 1. Completion of Budget 2020 compliances

System is now 100% compliances to Budget 2020. There are some changes in the system for budget 2020:

- i. Enhancement on TP3 report.  
(Kindly go to Reports > Government Report > Income Tax Report)
- ii. Enhancement on CP8D report.  
(Kindly go to Reports > Government Report > CP8D)
- iii. New Optional Deduction Rule for fertility treatment.
- iv. Departure Levy. This is claimable for the levy imposed on outbound air passenger performing UMRAH and pilgrimage to holy places. It is available for user to key in during payroll process.

A new leave type rule in the system that allow you to link two leave type together. For example, Hospitalization Leave(60 days) and Medical Leave(14 days). Whenever user take MC, it will also deduct the balance of the HL. So, if user had taken 4 days MC, and now only will have the balance of 56 days HL to apply.

### 1. Enhancement on leave balance details report

Now the report will show each employee on 1 single page instead of combining.

### 2. Enhanced EA Assistant Feature

Now those fields with the amount auto calculated by the system will be locked by the system to maintain the consistency of data between EA form and Borang E /CP8D. Only description, Pension or Annuities are allowed for user to modify amount manually.

2. Fixed leave cutoff at year end process not able to sort by employee
3. Fixed font size changed when edit report template
4. Fixed foreign worker cannot generate electronic bank payment file
5. Fixed if there were 2 approvers for the leave request and it will be auto approved
6. Fixed year end leave CF issue
7. Fixed First Time Setup wizard and Leave Setup wizard
