Object Class: Euclid

Special Containment Procedures: SCP-81055 must be kept within a Standard 3m x 3m x3m humanoid containment cell made to look like a bedroom with a Faraday cage around the entire chamber with two level 3 security guards posted at all times. Access to SCP-81055's Containment cell must be approved by no fewer than three(3) level 3 personnel. When face to face with SCP-81055, 81055 shows implicit apprehension. (See addendum 2) Therefore, communication with SCP-81055 is achieved by a terminal located outside the containment chamber with the capabilities of online communication. No electronic devices are permitted within 10m of SCP-81055's containment chamber. SCP-81055 is not to be let known of their containment at Site-88.

SCP-81055 possess Siren-like capabilities whereas, when an individual listens to SCP-81055's soothing voice they feel compelled to type "!surrender" into the chat box built into the communications device for SCP-81055, thus causing them to disappear from their current location. This chat box can extend to mobile devices, or any other device with an internet connection.

It is unknown at this time if personnel are incinerated or teleported into another dimension(see Test Log 81055-T1 for an example test). All foundation personnel entering or communicating with SCP-81055 are to immediately type "!resist" into the communication window, as this seems to negate the effects of SCP-81055. (Further testing is required.)

Description: SCP-81055 refers to itself as "Blossumcakes" with great emphasis on the misspelling of the word blossom. SCP-81055 is a virtual catgirl on the popular streaming website: [REDACTED]. SCP-81055 has pink/purple hair and tail, and is a height of approximately 152cm. SCP-81055 has feline features, one of which is cat ears instead of

human ears. These seem to share the same characteristic and heightened hearing similar to those of a feline. SCP-81055 is shown to always have a hair attachment. Whether it is biological or simply an accessory is yet to be known.

Another feature which is to be noted is the extremely miniature fangs SCP-81055 possesses, those of which fail to serve as viable weapons and tools. Nonetheless, SCP-81055 will attempt to use the fangs as a weapon attacking anyone who types "I resist" into the communication terminal. Only minor superficial injuries have been observed in test subjects.

SCP-81055 has deep blue eyes that causes the observer to feel an overwhelming sense of calm, even under extreme danger; whether this is intentional or not is yet to be determined. (Testing of this is currently ongoing)

Whenever SCP-81055 gets severely injured, the subject transforms into a common housecat (*Felis catus*) henceforth known as SCP-81055-1. SCP-81055-1 seems to be, in a sense, immortal, forming a tough membrane covered by needle-like hairs rendering the creature nearly indestructible by any common means of execution. Once SCP-81055-1 recovers to an adequate state the feline transforms back into SCP-81055. Upon successful execution of 81055, SCP-81055 gets reincarnated but with no memories of its past life. (See addendum 4).

Whether SCP-81055 is truly immortal or has a limited set of lives is yet to be determined and any testing on or about its life count is not to be conducted without O5 approval, as well as approval of the ethics committee. The difference in SCP-81055's reincarnation is subtle; whether it grows more drastic through more reincarnations is unknown due to the fact no prior evidence or proof of reincarnation existed prior to SCP-81055's containment. The first appearance of SCP-81055 is believed to have manifested itself around

SCP-81055 has shown great interest in streaming ASMR for her "community" of viewers on the streaming service ██████████. This "community" is to be foundation personnel and class-D personnel ONLY as 81055 is indiscriminate in its attacks.

Currently SCP-81055 is allowed to stream from Wednesday through Sunday at 6pm EST and is allowed 4 to 7 hours per night. Any and all attempts of a containment breach will result in loss of streaming privileges.

SCP-81055 refers to her community as "Lil Cheesecakes" and is said to keep all of them in a "basement" within her "Cafe". Certain individuals within her containment have attempted to escape and have been hunted down by SCP-81055 and subsequently brought back to the basement, on occasion this individual will be put into "Confinement" where SCP-81055 can closely monitor all activities performed by the individuals. SCP-81055 will proceed to give the individual a fork, only to take the fork away when 81055 believes they have misbehaved. The Foundation is prepared to assist individuals who have managed to escape the Basement for any and all information.

Scp-81055 has created quite the extensive "lore" for itself.. (Please refer to SCP-81055's wiki for a complete understanding of her lore).. Foundation scientists believe she will grow at unprecedented rates.

SCP-81055 has been heard talking to, and interacting with individuals during her daily streams, however, when D-class personnel were sent to investigate, SCP-81055 was alone in the room with no other entity in sight(except for the occasional cricket that appears, in which case, SCP-81055 exhibits great hostility towards this cricket) These instances warrant further investigation.

SCP-81055 has shown great interest in the horror film industry to the point of nearly exhausting all Foundation resources. When tested for how she would react to a moderately horror themed setting in her physical form, SCP-81055 (DATA EXPUNGED) (See addendum 3). After this incident all future tests on SCP-81055's mental fortitude have been suspended until further notice.

SCP-81055 Believes herself to have "Cat-Like Reflexes". This notion has been disproven. After extensive testing, it was deemed the subject had worse reflexes than the average 60 year old. SCP-81055 insisted on further testing. No further testing is required.

SCP-81055 has a constant need of a night light to keep her "Safe" during the night, when asked safe from what, 81055 responded with "The darkness and what lies inside". This has brought up concerns whether or not SCP-81055 is aware of SCP-017 and is possibly connected in some way.

- 1x "Very Comfy" chair (Approved)
- 1x Wifi Router (Denied)
- 1x Capability of not dropping the mic (Denied)
- 1x Mini Fridge (Approved)
- 1x Fan (Approved)
- 1x TV (Approved)
- 1x Fluffy white rug (Approved)
- 1x Baby Blanket (Denied)
- 1x Pink Baby Blanket (Approved)
- 1x Booster Seat (Approved and encouraged to use)
- 4x Emergency Flashlights (Approved)
- 1x "Wall of Cuties" (Pending)
- 1x Set of Stuffed Animals (Approved)
- 1x Night Light (Approved)(See Footnote 1)
- 1x Shelf of Honey Mustard (Denied and to be replaced with Ketchup)
- 1x Bug Killing Device (Denied use of Hands or Fangs encouraged)

Addendum 1:

In an attempt to recontain SCP-81055 foundation sent out MTF-████████. Also known as ██████████. They have so far proven effective in infiltrating and earning SCP-81055's trust and some moderation/VIP status. The MTF unit is actively making attempts to contain the SCP but as of now have made little to no progress in learning the whereabouts or ways to recontain SCP-81055.

Addendum 2:

The following is an interview between Dr. ██████████ and SCP-81055:

Interviewer: Dr. ██████████, Site-88

Interviewee: SCP-81055

Dr. ██████████: So SCP-81055, when did you notice you started manifesting your "powers" and when did you notice you became trapped behind the screen?

SCP-81055: One day I just noticed I looked different. I wasn't myself, I looked like the model I was working on! I even grew a tail! I remember it was sometime around ██████████ I was so scared and nervous I didn't know what to do! There was a countdown to going "live on ██████████" for some ASMR which is what I was practising on at the time. Something deep inside of me was excited for it and wanted to act like normal.

Dr. ██████████: How is it that you interact with chat and make the sounds with your ... (checks notes) "3DIO"?

SCP-81055: I just imagine using my 3DIO in my mind how it would sound if my real body was doing the triggers! That's why I think it's so effective. But those damn Resistance members keep resisting and bullying me! Like DA HECK??

Dr. ██████████: That's all for the interview today SCP-81055 there will be more questions tomorrow.

Addendum 3:

Date: June ██████████ ██████████.

Head Researcher: ██████████ "Monty"

Test Item(s): Cloth (Black), Spider silk, Pair of Red Spectacles, Blackout Curtains, 100YD of Privacy Film.

SCP-81055 was removed from her room, the reasoning being "Maintenance". During this time D-class personnel, D-4200, D-5234, and D-1999 made modifications to SCP-81055's containment cell by setting blackout curtains over the entrance of the room, privacy film on all surfaces and spider silk sewn across the room. D-2342 was instructed to put the pitch black cloth over himself with the red spectacles over his eyes. D-2342 was instructed to face the wall and to only turn around when instructed. D-2342 received a set of instructions to slowly back up as soon as he heard footsteps and then turn around as previously instructed. When provided in this environment and conditions it is to replicate being in a horror situation to make SCP-81055 feel and react to such a scenario. After test preparation was completed 81055 was escorted back to her cell and guards were ordered to not to cross the hallway with her and ensure she entered containment.

The following happened 3 minutes and 21 seconds after SCP-81055 was left alone inside her containment cell:

Upon entering the cell, SCP-81055 was engulfed in complete darkness and D-2342 began performing his instructions. SCP-81055 reacted like a cat would be expected to and arched her back and recoiled up in surprise like a cat in fright and scampered around the entrance and started hissing and crying then bumped into the door and proceeded to attempt breaking containment. The two security guards were more than enough to escort 81055 back into her cell though SCP-81055's profound cries of what can only be named as "Gurgling sounds of torture and fear". It took two weeks for SCP-81055 to recover from her "traumatic" experience. D-Class 2342 fell into a depressive state and failed to recover then expiring soon after, with his final words being "How could we do that to such a previously unthreatening defenceless baby fanged catgirl... we should never have bullied such wholesome bright sunshine...". It is unknown as of yet whether the expiration of the D-Class personnel was due to an anomalous effect or strictly bearing witness to the test. SCP-81055 was given Class-A amnesties

Addendum 4:

On one occasion SCP-81055 severely injured herself by just existing, during this incident SCP-81055 transformed into SCP-81055-1. All self-inflicted injuries remained in the corresponding sections on the recently transformed subject but the recovery rate was astonishing, which appeared to be at a rate of 15x the normal human rate. Shortly after, SCP-81055 transformed back into her human form with no memories of the time of the incident nor the time spent in her SCP-81055-1 form.

Test Log 81055-T1:

D-class personnel, D-7777, was fitted with a GPS device and advised to approach SCP-81055's communication terminal. D-7777 proceeded to type "!surrender" into the terminal and, as expected, D-7777 was vaporized. The GPS device fell to the ground and it seemed no other items other than the test subject and the clothes they were wearing were vaporized.
