# Central Powers Treaty



## 1. Purpose of The Central Powers Treaty

To promote a sense of friendship and general cooperation between the states of this organization in the areas of diplomacy, free travel, free trade, mutual defense and regional and national security.

## 2. Diplomacy

The parties to this treaty agree on the adoption of a common understanding of foreign policy and the establishment of diplomatic norms between the signatories of this treaty.

- 2a. At the earliest convenience, the signatories of this treaty agree to establish embassies within the other countries of the signatories
- 2b. The signatories agree to create and attend regular meetings of the leadership and diplomats at a previously agreed time to discuss regional matters.
- 2c. The signatories agree to a general philosophy of neutrality and non-intervention in conflicts that do not immediately concern the parties to this treaty.

### 3. Free Travel

The parties to this treaty agree to allow citizens free travel in the lands in their respective nations within reason.

- 3a. Not attempting to infringe upon private property and the rights of property owners, persons will be allowed to travel from each of the respective countries in places that are generally legally accessible to the public without restriction.
- 3b. Cooperation on the creation of public infrastructure connecting the two countries will be considered, agreed on, and shared funding and labor will be provided for such projects.

#### 4. Free Trade

The parties to this treaty agree to promote free trade between the citizens of their respective countries.

- 4a. Not attempting to infringe upon the rights of shop owners to set their own prices, the signatories of this treaty will encourage shop owners to attempt to make good deals with citizens of allied nations so long as they are still profitable.
- 4b. No tariffs will be placed on the signatories of this treaty by one another.

# 5. Mutual Defense and Security

The parties to this treaty agree to cooperate for the purposes of mutual defense.

*5a.* The signatories of this treaty will share military intelligence with one another.

*5b.* The signatories of this treaty will, not violating individual property rights, allow access to defensive infrastructure for purposes of promoting regional security and stability.

# 6. Additional members to this organization

In the event one of the signatories proposes an additional member the matter will be voted on and new additions must be agreed upon unanimously.

# 7. Duration of this Treaty

This treaty will take effect on May 14th, 2020 and be revisited on August 14th, 2020.
