# THE SHIT JUST WORKS CONSTITUTION

## PREAMBLE

---

In the interest of providing a solid legal foundation for the Free City of Alexandria and on the basis of creating a welcoming country for all newfriends in which shit just works, we hereby establish this Constitution of the Free City of Alexandria.

## ARTICLE I

---

§ 1. This constitution covers all territories of the Free City of Alexandria.

§ 2. The role of head of state is shared between the members of the City Council of Alexandria

§ 3. The City Council of Alexandria gets the final say in any decisions regarding the national interests of the Free City of Alexandria.

---

## ARTICLE II

---

§ 1. The City Council of Alexandria is advised by the Cabinet of Alexandria. The Cabinet of Alexandria consists of the Ministers and the Representatives.

§ 2. The Ministers serve the role of advising the City Council in matters of the state.

§ 3. All ministers are appointed by the Council and can be removed by the Council.

§ 4. The Representatives serve the role of representing the interests of the citizens of Alexandria in discussions regarding matters of state.

§ 5. There are always two (2) representatives.

**§ 6.** The Representatives are elected by the citizens and serve terms of 1 month. Elections are held on the 2<sup>nd</sup> Sunday of every month.

**§ 7.1** In an election, the two candidates with the most votes get the role of representative.

**§ 7.2** In the event of a tie between multiple candidates, a tie breaker election will be held on the Monday after the 2<sup>nd</sup> Sunday of the month. In a tie breaker election, only the candidates that are tied will be available as choices.

**§ 7.3** In the event of the tie breaker election also being tied, the Ministers will hold a vote between the tied candidates. The minister vote will be held on the Tuesday after the 2<sup>nd</sup> Sunday of the month.

**§ 7.4** In the event of the minister vote also being tied, the Council will pick one of the tied candidates. The council must pick their candidates no later than the Wednesday after the 2<sup>nd</sup> Sunday of the month.

**§ 7.5** Until all the relevant tie breaker elections have been held, the representatives from the previous term keep their position.

**§ 8.** The right to vote is given to any person who has been a citizen of Alexandria for more than two (2) weeks, is not currently serving any sentence for crimes within the Free City of Alexandria and does not currently serve as a minister of Alexandria. In addition, anyone with a dual citizenship must spend the majority of their time in Alexandria or one of the nations approved in § 9.

**§ 9.** Dual citizens who spend the majority of their time in the following nations can still participate and vote in Alexandrian elections: Accelerada, Miletos, Nowhere, Trevie Kingdom.

**§ 10.** The list of countries approved in § 9 can be amended by the City Council of Alexandria.

**§ 11.** The right to stand for election for the position of representative is given to any person who is eligible to vote in the elections as defined by § 8.

**§ 12.** Elections are held anonymously.

## ARTICLE III

---

**§ 1.** All laws of the Free City of Alexandria must be approved by the City Council of Alexandria.

**§ 2.** All crimes within the Free City of Alexandria are defined by the Penal Code of Alexandria.

**§ 3.** When making important decisions regarding matters of state, the City Council must take the opinions of the members of the Cabinet of Alexandria into account.

## ARTICLE IV

---

**§ 1.** The Bureaus are responsible for practical bureaucratic and administrative aspects of running the country within their specific area.

**§ 2.** The City Council can create and disband bureaus as they see fit.

**§ 3.** Each bureau is led by the head(s) of the bureau.

**§ 4.** The head(s) of the bureaus are appointed by the City Council.

§ 5. The heads of the bureaus do not serve as members of the cabinet and do not advise the City Council.

§ 6. The head(s) of the bureaus can appoint people as members of their respective bureau to help fulfil the tasks of the bureau.

## ARTICLE V

---

§ 1. The Guides are responsible for helping new players learn about the plugins of the server and the laws of Alexandria.

§ 2. Guides are appointed by the city council.

§ 3. Guides have the right to give new players the role of citizen in the Discord and add them to the Namelayer group.

## ARTICLE VI

---

§ 1.1 The personal right to freedom is inviolable. No citizen can have their right to freedom violated on the basis of race, gender identity, sexuality, nationality, religious affiliation or political affiliation.

§ 1.2 The right to freedom can only be violated in accordance with the law.

§ 2. Any citizen who is arrested (pearled) must be sentenced as soon as possible after their pearling in accordance with the law.

§ 3. Citizens have the right to freely express their concerns about political events, as long as it is expressed with all due respect.

## ARTICLE VII

---

§ 1. This constitution can be amended as needed. Any amendments must happen with consensus from all of the City Council.

---

## ARTICLE VIII

---

§ 1. This constitution is effective immediately as of its signing by all members of the City Council. It shall be announced in the discord and added to the wiki page for the Free City of Alexandria, so that it is commonly available to all those whom it may concern.
